From the President's Desk

A new year and a new (AIPG Section) President; both occasions bring resolutions and goals, and I am feeling the excitement and responsibility of the time and the office. The executive board met recently and discussed what we would like to accomplish during 2005, and what we focused on are ways to increase the level of member participation. Even though the primary goal is not original, it is important. Our success would be measured by an increase in the attendance at the four or five regular dinner meetings being planned, as well as the expansion of member participation in the two major commitments we made last year, to pass a Professional Geologist licensure Bill, and to sponsor and organize the 2007 AIPG Annual Meeting.

The reality of increasing member participation in any organization that is dependent on volunteers is to create and sustain a perceived value in that participation. To that end, it is the responsibility of the leadership to do more than ask for your involvement, but to also make the organization valuable to you. We have tried to think of ways to do that and certainly one way is to make AIPG professionally relevant. We think that the Michigan Section has done this in the past and we are intent on continuing that emphasis.

Specifically, we are planning our first regular meeting in March around upcoming revisions in the MDEQ Operational Memorandum (Op Memo) #4, which will apparently recommend more standardized methods for various investigation and monitoring techniques. Several Section members have also volunteered to be part of a review group to offer input to the MDEQ regarding certain portions of the Op Memo. Kevin Lund, the Section Vice President, has initiated these involvements and has contributed an article in this newsletter, which includes the March meeting details.

Another membership value, which I think is often overlooked, is that we are part of a national professional organization. What I heard while attending the Annual AIPG meeting last fall is that AIPG National is committed to increasing their

practical value to you. One of the programs planned for launch in March 2005 is the availability of on-line courses in various aspects of geological training. The courses will be designed to qualify for Continuing Education Units (CEUs) and give members a convenient and inexpensive way of expanding their professional expertise and meeting licensure or employer requirements.

We hope what we have planned for the Section is of interest, and you will exhibit that interest by participating in the upcoming events. Also, the leadership is always looking for member input as to how we can improve the Section, and for those of you that want to get involved at a more active (committee or officer) level.

She will speak at the March 30 meeting of the AIPG Michigan Chapter. It will be held at Tony M’s Banquet at 3420 South Creyts in Lansing, Michigan, on March 30. The Memo is expected to have attachments addressing the methods to evaluate and remediate Soil and Groundwater. Discussions will include evaluations of Groundwater Not in an Aquifer, Sediment, Soil Gas, Indoor Air, Methane, Non-Aqueous-Phase Liquids, Groundwater Modeling, Monitored Natural Attenuation, and In-Situ Injection. This is important for the DEQ to ensure consistency.

\$1,000 for Earth Science Granted to Maltby Middle School

The Michigan Section of the American Institute of Professional Geologists awarded a \$1,000 grant to Catherine Grieve, Science Coordinator at Brighton Area Schools' Maltby Middle School. The grant will be used for earth science. Grieve assisted by Science teacher Bruce Hedberg applied for and received this and other grants to improve their science curriculum. The regular science budget for the school is \$2,000 and grants help stretch it among 10 teachers and 800 students.

The grant from the Michigan AIPG Chapter has helped purchase kits on chemical weathering of rocks and kits on reading river sediments.

Remaining funds will help buy a flow table which simulates real-world water, air and magma events such as water cycles, air masses, jet streams, groundwater pollution and plate tectonics.

Because the Chapter felt it would have an impact on the most students, this is the first year the full grant has gone to one school.

Planning Minutes: Monday, December 20, 2004

The meeting began at 6:10 pm at the offices of STS, Inc. in Lansing. The following individuals were present: Adam Heft, Allan Blaske, Kevin Lund, Tim Woodburne, Ty Black, and Beth Rogers.

The fourth planning committee meeting was briefly summarized; specifically, the positives/negatives of the 2004 meeting, the decision to have the Park Place Hotel host our meeting, and a brief summary presented by each of the chairs.

The Michigan Section website is up and running; Adam Heft provided status, and asked for suggestions about additional information to include on the website (photographs, links, etc.) A series of photographs provided to Adam Heft by the Traverse City Visitors and Convention Bureau and the Park Place Hotel were circulated for discussion.

Adam Heft provided a brief summary about the status of the hotel contract with the Park Place Hotel, and the need to proceed with finalizing the details. A suggestion was made to use a general "placeholder" contract to secure our space, with a more detailed contract to be issued later. Adam Heft will discuss this issue with Bill Siok of National for guidance, and see if this is acceptable. If so, and if also acceptable to the Park Place Hotel, a placeholder contract should be in place with the Park Place Hotel by the end of January 2005.

A brief discussion was held regarding National's scheduling requirements for the meeting and how our plans may accommodate those requirements. It is currently believed that the problems generated by the required timing of the awards banquet can be fixed using an off-site location for that event.

Adam Heft indicated that National and the other General Chairs for the 2005 and 2006 meetings will be having a conference call the second week of January 2005 to discuss issues. Any questions or suggestions should be forwarded to Adam before that time to include in the discussion.

Each of the chairmen provided a brief report on the status of their specific tasks. The program, exhibit, and registration chairs had nothing specific to report, as ideas were still being formulated. The short course chair presented a list of possible short courses and individuals to conduct them. The field

trip chair had a list of possible trips, including two or three tentative trips that individuals would be willing to lead (a trip to the UP iron mines, Ice Mountain, and a glacial trip for the TC area). The publicity chair provided information before the meeting stating that the list of potential sponsors/advertisers would be revised and sent to each of the chairs between Christmas and New Year 2004. This will be the interim final list, and will be the basis for contacts. He asked that everyone review and add to the list. The finance chair provided a document summary depicting potential milestones for our planning process, and a very preliminary budget document that will be revised as we go forward. The rationale for the assumptions for both documents was summarized. The spouse program chair provided information prior to the meeting, which included a list of potential trips.

Several other issues were discussed during the meeting. It was decided that to be sure that contacts with the various Michigan universities and their students don't slip through the cracks, that we would add a Student Liaison Chair to the Planning Committee. This will be publicized in the next newsletter, which will be sent to members the first week of February 2005.

As part of the next newsletter, it was decided to include a questionnaire for the members specifically regarding the annual meeting. This will provide specific information about what is being planned, ask what specific events that members would like to see included (if not already on our list), and ask for a commitment from members planning to attend the meeting.

A suggestion was made to include as part of the exhibits a rock and mineral show (perhaps on one day) that would be open to the public. This issue will be discussed further at the next planning meeting. Another suggestion was made by Kevin Lund that we could perhaps offer a very early registration to Michigan Section members (a year or two in advance) to help get commitments and some early registration money). This issue will need to be discussed with National during the conference call in January.

In response to a request for suggestions for items to include in the registration pack and or similar items, a suggestion was made to have a silent auction for some particular item(s) during the meeting.

The planning group was also in concurrence that a potential Keynote speaker should be identified by June 2005, and preliminary contacts made with that individual. This issue will be revisited at the next planning committee meeting.

Finally, the next planning meeting date was set. The sixth planning committee meeting will be held on

Monday, February 21, 2005 at 6:00 pm in the offices of either SME or Strata (the location will be finalized by early January 2005. Maps and directions will be furnished prior to the meeting. The meeting finished at 7:40 pm.
