### From the President's Desk

Over the past three years I have had the opportunity to talk one-on-one with members about AIPG and discuss issues with fellow geologists at various section meetings located across the State, including the National Meeting in Kentucky. I have asked many of you for ideas and suggestions on how AIPG could become a stronger association that meets the needs of its members. One comment that I have repeatedly heard is that AIPG needs to better communicate the value of membership, in other words answer the question, "Why should I join AIPG?" This is such a fundamental and important question to any association, and certainly to the growth of the Michigan Section of AIPG, that I would like to share my thoughts and invite you to send me your ideas on what you believe are important and relevant to Michigan geologists.

### 2007 Annual Meeting Update

It is time once again for an update on the status of the planning for the 2007 national meeting. As you are aware from my previous articles, the venue has been set and a contract executed. We are currently in the process of finalizing the contract with the company that will handle the setup of the exhibit area.

My last article informed you that the Program Chair position was vacant. I am pleased to inform you that Eric Wallis has stepped up and filled the position. While we have each of the planning chairs filled, we can always use the input and help from the members of the section. Everyone is always welcome to attend the Planning Committee meetings.

In late December, the Planning Committee sent out letters to potential sponsors and advertisers for the meeting. Exhibitor letters will be sent out in the next few weeks. We have had a few positive responses. but although it is still early, we would like to see more. Everyone can help with this. The costs are not unreasonable, and even if individuals are unable to personally contribute funds, please ask your employers to consider contributing. A business card add in the program book is only \$75 (larger adds are more). Sponsorship of the meeting can be in any amount, although we have minimum amounts for certain events. The money can be submitted in installments (with a commitment for a total amount) if that is preferred. The Planning Committee is hoping to have around 30 exhibitors, and up to a few hundred meeting attendees, so either sponsorship or advertising will be a good way to promote yourself or your company's business to a national audience. If you are unable to help financially, please offer your time, or commit to attending the 2007 meeting. We will need help with monitoring events during the meeting, manning the registration booth, etc., and volunteers to help with these tasks (even if for a day) will be welcome. This is the first time in the organization's 44 years that Michigan has hosted the meeting; let's make it one that our colleagues from around the country will remember.

Students, we have not forgotten about you. First, and as usual at these national meetings, it is a good way for you to meet the experts in the field. We will be having a "Career Day" where you will be able to meet with prospective employers and arrange private interviews. Students (both graduate and undergraduate) will also be able to present posters depicting their research. The best posters in the graduate and undergraduate categories will be awarded cash prizes to support their education efforts. As an added incentive, the Planning Committee has decided to have either a nominal (\$10) fee for student registration, or waive the registration cost altogether. Other incentives may be implemented, depending on how the planning process proceeds.

The Planning Committee intends to have the final list of field trips, spouse tours, short courses, and evening events completed by June 1, 2006. The selected events are based on member responses and availability of someone to lead them.

The Michigan Section will have a booth at the 2006 meeting in Minneapolis to promote the 2007 meeting. We intend to open registrations for the

2007 meeting at that time; registration during the 2006 meeting will be at a reduced rate. If you plan to attend the 2006 meeting, stop by our booth and get registered for the meeting in Traverse City. It is a good way to save costs, get signed up for the events you are interested in (without worry that the event will be full), and it will also help the Planning Committee to get an early idea of the potential attendance for the 2007 meeting.

## INQUIRY ON MICHIGAN LICENSURE OF GEOLOGIST

As you may know, over the past two years the Michigan Section of the AIPG has been leading efforts to pass House Bills 4440-4442, which would provide for the licensure of professional geologists in the State of Michigan. This effort has been a significant undertaking requiring a great deal of time and energy, which we believe will ultimately benefit our profession as a whole, us individually, as well as public we serve.

Throughout this process we have communicated with (and solicited feedback from) other professional groups who may be stakeholders in this effort such as Michigan Department of Environmental Quality, Michigan Environmental Council, Michigan Groundwater Association, Michigan Association of Environmental Professionals, Michigan Aggregate Association, and Michigan Oil & Gas Association. In addition, we successfully met with the Michigan Society of Professional Engineers (MSPE) to resolve concerns that they had to the initial bill language and have garnered their support for our effort. In addition to support from MSPE we have received letters of Support from organizations such as:

- 1. American Institute of Professional Geologists
- 2. Michigan Basin Geology Society
- 3. Michigan Waste Industries Association
- 4. Michigan Association of Planners
- 5. Michigan Water Environment Association

If passed, we believe this legislation will enhance the credibility of professional geologists, protect the public's health, safety, welfare and the environment,

and demonstrate a higher level of educational attainment and technical competency.

We believe that the areas of practice that geologists operate in is of fundamental importance to public safety, not only to promote the wise and safe extraction of minerals, water, and energy resources, but also to protect the public from natural disasters, environmental contamination, and to provide information to other licensed professionals which is essential for safe and responsible land use.

The bills, and information regarding these bills -including current status, Frequently Asked
Questions, a Fact Sheet, and Letters of Support -are currently on the Section home page at
<a href="http://mi.aipg.org">http://mi.aipg.org</a>. However, discussion on the merits
of the proposed bills should continue. All AIPG
members and geologists working in Michigan may
not be in agreement with proposed licensure
legislation or may not be fully informed regarding
these bills, which are now before the Regulatory
Reform Committee in the Michigan State House of
Representatives.

The Michigan Section Executive Committee is interested in your comments regarding licensure of geologists. The Executive Committee believe that professional discussion regarding licensure is an ongoing process and if appropriately applied your input will result in even better legislation.

The Executive Committee seeks your input to which we will present information in the next newsletters that address questions or concerns that are raised. Please reply including:

- 1) Are you a Michigan Resident?
- 2) Do you support the licensure of geologists? Why or why not?
- 3) Do you have any specific comments or issues to improve the legislation?
- 4) Are you able to assist in this legislative effort?
- 5) Are you a member of another geology-related technical or professional organization? If you are, does that organization support licensure?
- 6) What specialties or areas of geology do you practice?
- 7) Are you licensed as a geologist in any other states? If so, what states?
- 8) Do you work exclusively in Michigan? If no, what other states do you work? Do those states require licensure?
- 9) How many years of experience do you have practicing geology?
