Another topic that we have been working on is drafting a letter that will be sent to the Michigan legislators regarding House Bill No. 4908 and Senate Bill No. 436. The bill proposes amendments to Public Act 451, 1994, as amended, that would require the certification and signature of professional engineers for remedial action plans (RAPs) prepared under the requirements of Part 201 of P.A. 451. Our letter requests that the legislators consider the fact that skilled geologists are just as necessary to RAP process as engineers, and in many cases, more so and require that geologists also provide the professional certification for these documents. We will be posting a copy of the letter on the website.

Speaking of the website, I am pleased to announce that we have been working on developing a new website for the Michigan Section. Our new website is intended to be more interactive, maintain current information, and be more visually interesting than the previous website. The website has been launched: please feel free to check it out. Additional details regarding the new website are included in a separate article in this newsletter. If you have any suggestions for additional information, links, or you would like to submit geology related photographs, we will be happy to post them. Please contact Adam Heft regarding any suggestions or submittals. Wendy Davidson from National has been very busy making our vision a reality. Thanks to both Wendy and Adam!!

We have just a few upcoming items to discuss at this point. Our September meeting will include a discussion on C_{sat} and mixing zones presented by the MDEQ RRD. There have been many questions regarding the effects of multiple contaminants on C_{sat}

at sites across the state, and this presentation will answer many of those questions. Several mixing zone questions have also been raised, including storm sewer receptors and the applicability of closure to sites with mixing zones. Ms. Patty Brandt, Part 201 Specialist, and I will give the presentation on these topics at Tony Ms in Lansing, Michigan on September 17, 2009.

Our final meeting of the year will be on December 3, 2009 at Western Michigan University in Kalamazoo, Michigan. I am very excited about this meeting. The meeting will kickoff with a tour of the Core Lab followed by dinner at the Fetzer Center with a presentation entitled "A Geological Perspective on Global Climate Change." Section Officers Reports

<u>President:</u> Information presented in the "From the President's Desk" article above.

Vice President: As the current Vice President, former Treasurer, and Chairman of the Awards Committee it is my pleasure to provide the following update to Section members. As discussed at the 2008 annual meeting, the Executive Committee voted to place \$30,000 of Section resources into five (5) Certificates of Deposits (CD's) that mature on 12month intervals (i.e. 12-month, 24-month, 36-month, 48-month and 60-month). The CD's are in \$6,000 increments and have a variable yield between 4% and 5% annually. Interest on the CD's will generate approximate \$1,500 per year, which will be reinvested and/or utilized to fund educational grants or scholarships. The Section also has approximately \$10,000 in other cash reserves that are utilized for normal operations (i.e. meeting costs, etc...). Given that as a Section we are committed to fostering the growth of geosciences with the younger generation, I strongly encourage every member to highlight the availability of the educational grants to their local schools, as we have traditionally struggled to award these grants which have historically been as high as \$1,000. Details of the grant application process are available on the updated website.

<u>Treasurer:</u> No report.

<u>Secretary:</u> No report. I can say the economy is in unchartered waters (at least for my generation), and we all play a key role in collectively and aggressively strengthening the organizations muscle, whether it be in AIPG or with our current employer. We must remain true to our core values and competencies so that we can successfully overcome the uncertainties and move to a brighter future.

National Advisory Board Representative Executive Committee Meeting Summary

I am a 2009 National Advisory Board representative, and feel that I should share with the Michigan Section information from the Executive Committee meetings. There have been two of the three meetings held so far this year.

The first meeting was held in Tucson, Arizona on February 13th. As part of this meeting I was part of a committee charged with reviewing and revising the AIPG strategic plan. Significant progress was made in this regard in a pre-meeting meeting the day before the regular meeting. The plan was subsequently reviewed by all members of the executive committee and is planned to be approved at the annual meeting in October. It will thereafter be available to members once it is posted on the AIPG national website.

One of the main points of the strategic plan is to find a way to offer additional value to AIPG members. If this can be accomplished, then the other goals (increasing membership, diversifying sources of revenue, strengthening the sections, etc.) will fall into place. With that said, I am asking that each of our members take a few minutes and decide what AIPG means to you, what you like, and what could be done to improve the organization. For those members that have a problem with the way things are done, speak up; this is your chance to provide input directly to the national executive committee. Both compliments and criticisms are welcome.

Other business discussed during the February meeting included a summary of institute finances and the impact of the economy on AIPG investments, a summary of the 2008 annual meeting and a discussion of meeting locations for the next several annual meetings, information on the 2009 scholarships and awards, a summary of nominations of officers for 2010 and information on the CPD program implementation and lack of participation. The final item discussed was a \$5 membership dues increase, which was deemed necessary because of the increased costs associated with payment of dues via credit cards and the fees charged to AIPG for this service.

The second meeting was held on June 6th in Westminster, Colorado. This meeting continued discussions on the topics covered during the February meeting, and also included discussions about the relationship between AIPG and the AIPG Foundation. The Executive Committee also heard from a representative of the Geological Society of London, and a representative of AGI.

The discussion on participation in CPD was continued from the February meeting. One of the main concerns is the apparent lack of participation among members; anyone that became a CPG after July 1, 2006 is required to provide documentation on continuing education efforts. What was not made clear is that members should use the AIPG on-line system for this purpose. The on-line system is very easy to use, and is visible to the CPD review committee that ensures members are complying with this requirement. Please take a few minutes to upload your information into the system. It may take a few minutes the first time, but once you have set up your basic information, entry of specific items goes quickly.

MDEQ-RRD Updates

Program Redesign

Additional stakeholder meetings dates have been scheduled for July 14th (liable party obligations), August 6th (liability and enforcement provisions), August 26th (conceptual presentation for criteria revisions-likely webcast), and September 10th (criteria). Details on meeting times and materials for discussion will be available closer to the scheduled dates.

Portions of the proposed statutory language (e.g., inquiry, due care, release reporting, etc.) are being prepared and will be provided for comments concurrent with the upcoming meetings.

American Recovery and Reinvestment Act

EPA and the Office of Management and Budget have finally completed their guidance, and Michigan is in the process of redrafting the grant application for submittal this week. The grant amount allocated to Michigan is slightly less than \$7.2 million from the American Recovery and Reinvestment Act, and a number of projects have been identified to begin to work on this year.

MDEQ is utilizing the current contracting infrastructure and plan to maximize the flow thru to consultants by not using any grant monies to pay for staff. Reporting templates to address the grant requirements for quarterly reporting are under development, since it will be important to carefully track the grant expenditures due to the high profile of the American Recovery and Reinvestment grant effort. CAVES AND KARST OF THE MITCHELL PLATEAU SOUTH CENTRAL INDIANA

SATURDAY OCTOBER 24th and SUNDAY OCTOBER 25th

This field excursion will allow participants the opportunity to experience spelunking first hand with the guidance of several experienced members of the Eastern Indiana Grotto. The cave(s) we will visit will be easy, mostly walking, which have been relatively left unplundered of the karst formations. One suggested cave, Donohue Cave, is walking distance from the suggested hotel and may be the first cave we will enter on Saturday. In the evening we will visit an additional cave for those interested. The Wesley Chapel Gulf may also be visited which is a series of karst sinkholes adjoined into one large depression of over 1,000 feet in length. On the return trip Sunday, Todd Thompson and Brian Keith of the Indiana Geological Survey will guide the group to a number of karst and geologic features of the Salem and St. Louis Limestones between Bedford and Bloomington. We will also view a Salem Limestone quarry where the famous "Indiana Limestone" is quarried.

<u>Recommended Lodging:</u> Holiday Inn Express Hotel & Suites Bedford, 2800 Express Lane, Bedford, Indiana 47421, (812) 279-1206. Please make your own reservations for lodging *before October 1st*. A block of rooms has been assigned to the "MBGS" group. *The hotel is booked for this weekend and the block will be dropped if not reserved.*

Who can participate: Open to MBGS members only. Become a member and join in on the field trip if you are not a member! An application is attached.

Cost: \$10 per person to cover printed materials and rental equipment.

Clothing and Equipment Recommendations: Caving is wet and dirty. Cave temperatures average approximately 55 degrees. Old clothing which can get muddy, preferably of synthetic blends or light wool, such as long pants and a long sleeved shirt are suggested. An old light jacket and wool socks are recommended due to the cave temperatures. Coveralls are also recommended. Wear old tennis shoes or light boots which can get soaked and muddy. Knee pads are also highly recommended. Although the caves are primarily walking caves, knee pads will make the occasional crawls at entrances and exits much more comfortable. Bring leather gloves and a small knapsack/fanny pack to carry your small spare flashlight, extra batteries and water bottle. We will provide hard hats and electric lamps. Everyone is required to provide their own AA batteries. Bring 12 AA alkaline batteries at a minimum per person (for use and backup).

<u>Restrictions:</u> If you are highly claustrophobic, this may not be a trip for you. If you get claustrophobic during the trip, enough Eastern Indiana Grotto guides will be available to assist with your return exit from the cave. Much of the cave travel is like walking in an irregular shaped corridor or hallway.

Participation Limit: 20 Participants total.

Registration Deadline: Friday, October 16th.

<u>What is Provided:</u> Instruction and guidance for entering into and through the caves, hard hats and electric lamps, printed materials. All travel, lodging and meals are the responsibility of the participants.
