From the President's Desk

There is a saying often credited to the Chinese: "May you live in interesting times". How much others are responsible for the times in which we live is for others to debate. However, there can be little debate that we do in fact live in most interesting times.

A large portion of our membership is involved with compliance issues related to environmental regulations. With last month's signing into law amendments to Michigan's environmental regulations, there are new considerations for a large part of the environmental regulatory community. In March of this year we will continue to witness the ongoing dynamic of the apparent reversible reaction sequence MDEQ+MDNR↔MDNRE and possible additional changes within each department. These changes will affect those AIPG members who are regulators or advising clients within the regulated community.

Those of our membership who are active in petroleum exploration and production are in the midst of significant changes to their industry with production from formations previously uneconomical or unexplored. There have been improvements in exploration methods for the Trenton-Black River formation (Ordovician) in the southern part of the state. There have also been improvements in horizontal well production methods that make the Collingwood formation (Ordovician) in the northern portion of the Michigan basin an attractive exploration target. These advancements have created important exploration opportunities and brought new operators and capital to the Michigan oil patch. The effect of which includes the largest state land lease sale ever held in Michigan. State land lease sales generate substantial funding for the Michigan Natural Resources Trust Fund. These funds are often used to purchase or improve land for public use, a public benefit for which the petroleum industry gets little credit.

Developments in the mining industry, non ferric metals in particular, continue with the potential to improve the economic well being of portions of the

western upper peninsula. But the industry must satisfy government regulators and deal with portions of the public opposed to their operations.

And the most important overriding factor of our times, the poor state of the Michigan economy.

With this as our backdrop and as the President of the Michigan Section for 2011, I will strive to continue the good work initiated by my predecessors. We will continue to provide opportunities to become better informed on timely subject matter, network with our peers and enhance education and outreach activities within our communities. In doing this, our goal is to make the AIPG Michigan Section an asset to the geologists of our state in these interesting times.

V. December 2, 2010 Section Meeting. Dr. Harrison is the Director of the MGREE Michigan Basin Core Research Laboratory and presented "THE NEW SHALE PLAY (COLLINGWOOD)." As Director of the Michigan Basin Core Research Laboratory since its inception in 1982, Dr. Harrison maintains an ongoing interest in Stratigraphy, Sedimentology and Petroleum Geology of strata in the Michigan Basin. Current research activities are focused on reservoir characterization of old Devonian carbonate oil reservoirs in Michigan, with the principal aim of their redevelopment for additional oil recovery.

VI. Membership Database: Adam Heft discussed distribution of the AIPG-Michigan Section database that has been requested by several advertisers. Adam discussed similar discussions at AIPG-National centering around potential privacy issues. The Section Executive Committee decided not to circulate the membership database.

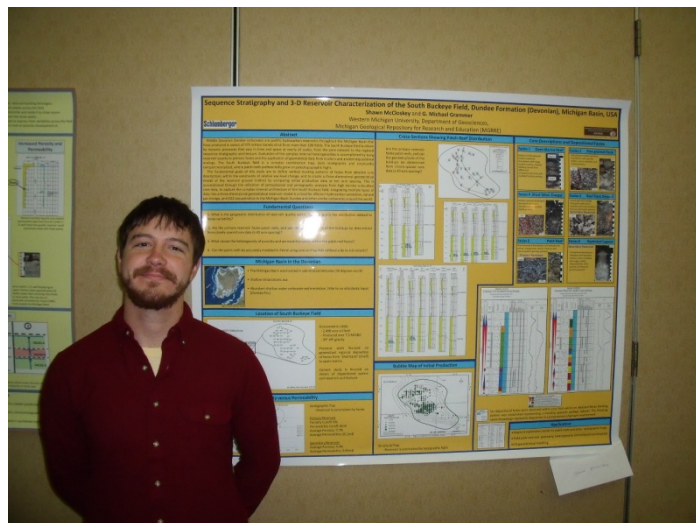
December Section Meeting Summary

Change... Change... Change... on the MDNRE Front

On December 14, 2010, Public Act 451, Part 201 was amended. The amendments include changes to definitions, cleanup categories, a schedule to revise the cleanup criteria in 2012, creation of a Response Activity Review Panel, changes to the Groundwater Surface Water pathway, inventory Residential closures, quarterly reporting, addition of No Further Action Reports, quarterly reporting of the number of Response Activity Plans approved and disapproved, quarterly reporting of the number of Baseline Environmental Assessment reports received, elimination of BEA rules, modification to the self-implementation language, and change in timeframes for DNRE review of Response Activity Plans to 150 days.

With all this change, the specific situations that require DNRE approval remain unchanged. The use of site specific criteria, development and use of mixing zone based criteria, use of ordinances, and use of Rule 705(5) and 705(6) provisions for groundwater protection, and in-situ injection all require DNRE approval.

Just to name a few of the changes that may affect how new business is done:

- Definition of Residential Closure – Section 20101(oo) - Means a facility at which the contamination has been addressed in a no further action report that satisfies the limited residential cleanup criteria under section 20120a(1)(c) or the site-specific residential cleanup criteria under sections 20120a(2) and 20120b, that contains land use or resource use restrictions, and that is approved by the

Department or is considered approved by the department under section 20120d.

- The amendments require the establishment of a response activity review panel to advise the Director on technical and scientific disputes, including disputes regarding assessment of risk, concerning response activity plans and no further action reports. The panel will consist of 15 members meeting minimum qualifications as stated in the amendments and appointed by the Director. Anyone interested in participating on the panel should contact Lynelle Marolf at 517-335-1104.
- The rules rescinded include Part 2 (site identification and tracking), Part 6 (Selection of Remedial Action), Part 8 (Site Assessment Model), and portions of Part 9 (BEAs). The rules that were retained include Part 5 (Response Activity), Part 7 (Cleanup Criteria), Portions of Part 9 (BEAs), and Part 10 (Due Care).

More details on the changes will be presented by DNRE Remediation Division staff at the next AIPG Chapter Meeting on March 3, 2010 at the Causeway Bay Hotel in Lansing. See the meeting announcement at the end of the newsletter.

On another note of change:

Governor Rick Snyder signed an executive order to divide the MDNRE back into two separate departments. The MDNRE will be abolished on March 13, 2011 and the Department of Natural Resources and Department of Environmental Quality will be re-created. The newly appointed Director of the MDNRE, Dan Wyant, will become director of the DEQ. The governor has indicated that the DNR, DEQ, and Department of Agriculture and Rural Development will be grouped together under the title "Quality of Life" in his newly proposed governmental structure. We will keep our membership updated on progress made on this front too.

In Memoriam...

Glenn Miller of Fowlerville passed away on January 3, 2011. A memorial service was held at the MacDonald Funeral Home, in Howell on Thursday January 6, 2011.



Glenn ran Sterling Drilling Company out of Brighton, a company founded by his father and one of the larger drilling firms in the 1950's in this area. During the 1960's, the business downsized, but Glenn continued it for many years, drilling mostly small residential wells and some monitoring wells. In 2010 Glenn auctioned off all the "old" equipment, but he kept

active focusing on geologic consulting. Glenn was a Life Member of the Michigan Ground Water Association and was a regular participant in their meetings. Glenn was also an active member of the Michigan Section of AIPG, and a regular meeting attendee.

One of our members that knew Glen shared the fact that Glen was formerly an Air Force pilot. Patty Brandt, Part 201 Specialist, will discuss the major changes that the newly enacted Part 201 amendments will have on the way facilities will be addressed including how the MDNRE RD will be acknowledging BEAs, reviewing Response Actions, issuing No Further Action Letters, and what the department’s goals will be in working the facilities.

Steve Cunningham, Environmental Quality Ordinance Specialist, will provide greater detail into the processes and procedures for the new Response Action Plans that the new amendments require. He will describe the voluntary self-implementation process and explain when department involvement and/or approval will be necessary according to the new amendments and existing laws. He will also describe the new No Further Action Report process and situations when a Post Closure Plan and a Post Closure Agreement will be necessary.

Rhonda Klann, Environmental Quality Part 201 BEA Specialist, will discuss the changes to the Baseline Environmental Assessment process that the new amendments bring. She will describe the changes to the timelines, how the new forms should be completed, and how due care is also affected by the new amendments.

This will be a meeting that you won’t want to miss. This is your opportunity to hear how the MDNRE RD will be implementing the new regulations and ask questions first hand.

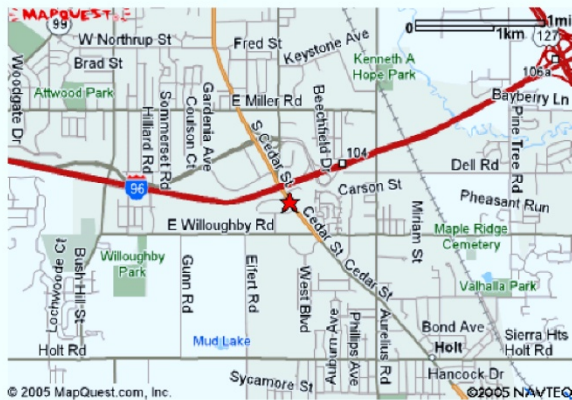
