The Hijacking of Science

Is anyone else bothered by the Human-Caused Global Warming Theory debate that is going on? Not the subject, since that is fodder for legitimate debate, but how the debate (or non-debate) is being conducted (by non-scientists I might add). As I see it, science and the scientific method are being hijacked in the name of politics and personal agendas by non-scientists who don't respect the scientific method. To read the news or listen to politicians, the matter is decided — global warming is occurring, man is significantly contributing to it or causing it, and drastic measures are needed to reverse the effects. This may or may not be true. These matters should be fodder for rational debate; however, to read the discourse, this is not the case for many.

It seems that more frequently, those who dare challenge the "conclusions" are attacked and criticized (I have read comparisons of them to Holocaust deniers) — not their science or data, but 'them' for their audacity to challenge the "accepted" theory. Since when do politicians seize control of scientific debate of a theory and stifle dissenting opinions? I know the Vatican did this to radical heretics like Galileo centuries ago — but aren't we beyond that? Where would our understanding of plate tectonics or evolution theory be if dissent and challenge was stifled? These non-scientists need to understand that scientific theory does not work this way - it demands dissent and alternative theories, not stifle them. One does not reach his conclusion, defend it at all costs and make all data observations fit the accepted model. Scientific theories are SUPPOSED to be vigorously challenged and questioned — its not a race to see who can conclude the "truth" first or provide the most radical consequence if he is right. Mind you, this cuts both ways — scientists and non-scientists on both sides of the issue are guilty of this type of dissentsquelching behavior.

Individually, we can (and should) have professional opinions on whether we think human-induced global warming is occurring — as scientists we need to recognize and respect the fact that the theory has not been proven either way. Further, as scientists, we are obligated to speak out and defend the scientific process that allows the free discussion and challenge of the theory being espoused. As geologists and scientists we know that scientific theories like climate change are subject to scrutiny and honest intellectual challenge. A theory does not become law until it is rigorously tested, challenged, and proven by peers in the scientific community. There is evidence to support anthropogenic effect on the climate. Equally, there is evidence to support natural cycles and influences. As geologists, we think in terms spanning millions of years, not

decades. We recognize that the planet is NEVER in equilibrium and constantly changing. Also, we recognize that the causes of change are equally known and unknown. On one hand, man can be a powerful change-inducing force, while at the same time being completely powerless to affect change.

Geologists need to take a firm position in the humancaused climate change debate — I propose that our position be that we will unequivocally and respectfully consider and debate all data supporting and contradicting the various positions being considered. We should assert at every opportunity that the scientific method requires that each side challenge its beliefs and that data should lead to a conclusion (subject to change based on more data) — a conclusion should not lead to how data is interpreted.

The Remediation and Redevelopment Division (RRD) extends an invitation to AIPG members to participate in the Peer Review Process for the RRD Operational Memorandum No. 4, Site Characterization and Verification of Remediation, Attachment 10, Groundwater Not In An Aquifer. This document addresses the required analysis and documentation for investigation and other response actions under Part 201 and Part 213.

To kick off the Peer Review Process, RRD will hold a meeting to present current issues associated with the determination that groundwater is not in an aquifer and factors considered in developing the operational memorandum.

The meeting is scheduled for: Wednesday, February 14, 2007 – 10:00 AM Dorothy Judd Conference Room Constitution Hall, 4th Floor, North Tower Lansing, Michigan

The presentation at this meeting will include a discussion of the requirements of the document and site-specific examples of application of the requirements.

We are hopeful that we can continue to move forward with this new bill being reintroduced with broad bipartisan support as part of latest legislative session. Some may recall that we ran into some unexpected opposition from the aggregate and oil & gas industries in the past; however, since we have met with those involved, we have developed new language to alleviate their concerns. 
